The Squad will be responsible:

- i) To conduct two surprise raids in the first month of the Academic Session.
- ii) To report any incidence of ragging to the undersigned immediately.

All students are advised to report any incidence of ragging or attempted ragging to the Anti Ragging Committee or the Anti Ragging Squad. In addition to above during working hours students are also allowed to directly see the Director in case of any attempt to ragging.

The students are cautioned that under the directions of Hon'ble Supreme Court, following action can be taken against the defaulters in addition to disciplinary action because of serious cases of ragging. The detailed instructions are available on PTU website www.ptu.ac.in

- 1. Punishment to be meted out shall be exemplary and justifiably harsh to act as deterrent against recurrence of such incidents.
- 2. Lodging of FIR with the Police
- 3. Cancellation of admission
- 4. Suspension from attending classes
- 5. Withholding/withdrawal of Scholarship & other benefits
- 6. Debarring from appearing in any test/Exams, or other evaluation process
- 7. Withhoding of results

- Debarring from representing the institution in any regional, national or international 8. meet, tournament, youth festival, etc.
- Rustication from the institution for period ranging from 1 to 4 Semester 9.
- Expulsion from the Institution and consequent debarring from admission to any other 10. institution.
- Collective punishment: when the persons committing or abetting the crime of ragging are 11. not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
